In consideration of receiving utilities provided by the City, the undersigned agrees to pay all utility charges when due each month for the residence/business located at the above address.

The utility charges include but are not limited to: water (potable), sewer, garbage and reconnect fees. The undersigned agrees to pay \$100.00 deposit upon signing of this application and agreement. If the account is current for a period of 2 fiscal years the deposit will be refunded upon application of said user. If the account is delinquent (not paid by the 20th) any time during the first 2 years, the deposit may not be refunded. The deposit may be applied to any amount owing to the account upon termination of services. If the undersigned does not leave a forwarding address upon termination, the funds may be dispersed to the Idaho State Unclaimed Funds Depository.

The undersigned agrees to pay all utility billings not later than the 20th of each month. Services may be discontinued any time on or after the 25th of each month in the event that the payment is not made on or before the 20th of the month.

The undersigned agrees the City can place a lien on the real property at the service address for the utility amount delinquent for a period of 90 days or longer. If a lien is unable to be placed on the real property the undersigned agrees the delinquent utility amount, for a period of 90 days or longer, will be sent to Statewide Collections.
